

Code of Conduct

EYP Sweden has established a Code of Conduct, which is to be signed by all participants of the session to ensure their safety during the Regional Sessions in 2019. It is based on the statues and values of EYP Sweden as an organisation, and on those of EYP International.

Should the Code of Conduct be violated by a participant, the matter will be discussed and acted upon by the National Board of EYP Sweden in dialogue with the session's President and Project Manager(s). EYP Sweden withholds the right to oust any participant at his or her own expense, should the Code of Conduct be violated.

Terms and Conditions

- 1. **Alcohol and other drugs are strictly prohibited** during all events organised by EYP Sweden. Consuming either, will lead to immediate expulsion from the session or otherwise severe repercussions. Please find the English and Swedish versions of EYP Sweden's alcohol policy attached below.
- 2. Smoking is allowed in restricted areas, as decided by the owners of the venues and/or Project Manager(s) of the session. **EYP Sweden does not encourage smoking**.
- 3. During the session, participants are not allowed to leave any of the venues without consulting the Project Manager(s) of the session.
- 4. All session participants are required to **participate in all scheduled elements** of the session. Should a participant find him- or herself unable to partake in a specific event, the Project Manager(s) of the session are to be consulted.
- 5. All participants of the session are to **treat each other equally** without exclusion on the basis gender, disability, sexual identity, ethnicity, religion or any other status in accordance to the values of EYP Sweden.
- 6. Officials are to be aware of high-risk peer situations and avoid placing themselves in a compromising or vulnerable position when meeting with children.

Alcohol Policy

EYP Sweden's activities primarily target university students and students of upper secondary school, and are organised in close collaboration with schools and teachers.

Concerning sessions EYP Sweden is to serve as a model for other National Committees within the European Youth Parliament when it comes to organising sessions of high academic and organisational quality, which simultaneously create memorable experiences for participants.

EYP Sweden's official policy shall be that no alcohol is to be consumed by the participants of a session or other happening in the duration of the event. The duration of an event is defined by the spectrum between the first and last part of its programme.

Delegates who are found intoxicated or in the possession of alcohol within the duration of a session will instantaneously be disqualified from selection. This is to be reported to the Head of Jury.

Officials who are found intoxicated or in the possession of alcohol within the duration of a session are to be reported to the Board of the session who in dialogue with representatives from the National Board of EYP Sweden will decide upon the repercussions.

During certain projects for university students or events with an age limit above 18 years the consummation of alcohol may be allowed in between scheduled parts of the programme if special permission has been obtained from the National Board.

Concerning all activities organised by EYP Sweden no alcohol will be offered and EYP Sweden will under no circumstances pay for the purchase of alcohol using association funds.

Alkoholpolicy

EUP Sveriges verksamhet riktas huvudsakligen till universitetsstudenter och gymnasieungdomar och har ett nära samarbete med skolor och lärare.

Gällande sessioner ska EUP Sverige verka som ett föredöme för andra nationalkommittéer inom EUP när det gäller att anordna sessioner av hög akademisk och organisatorisk kvalitet, som samtidigt skapar minnesvärda upplevelser för deltagarna.

EUP Sveriges officiella policy ska vara att ingen alkohol får förtäras av sessionens deltagare under en sessions gång eller andra projekt. Med sessioners och andra arrangemangs gång avses tiden från första till sista programpunkt.

Delegater som påträffas berusade eller innehavandes alkohol under sessionens gång blir omedelbart diskvalificerade från uttagning. Detta ska rapporteras till Head of Jury.

Officials som påträffas berusade eller innehavandes alkohol under sessionens gång ska rapporteras till Board som i samråd med representant för EUP Sveriges styrelse beslutar om rimlig åtgärd.

Under särskilda projekt för universitetsstudenter eller evenemang med en åldersgräns över 18 år kan förbrukning av alkohol tillåtas mellan programpunkterna om speciellt tillstånd inhämtas av styrelsen.

Gällande alla aktiviteter anordnade av EUP Sverige ska ingen alkohol erbjudas och EUP Sverige ska under inga omständigheter betala för alkoholinköp med föreningens medel.
