

# **Privacy Policy**

As part of our daily operations both within and outside the scope of our sessions, we process your personal information. This is why we are committed to protecting your individual rights, keeping your personal data safe and being transparent about our processing through this policy.

We may from now on shorten the name of our association from "European Youth Parliament Sweden" to "EYP Sweden", "we", "us" and "our". Please also note that EYP Sweden is an umbrella organisation under which regional and local boards exist. Therefore, sessions and events referred to EYP Sweden in this policy may in fact have been partly or completely organised by our regional or local boards.

#### **1.** Who is Responsible for your Personal Data?

The European Youth Parliament Sweden is the legal person who assumes the role of data controller, meaning we determine the purposes and means of processing.

#### 2. Why and what kinds of Personal Data do we Collect?

We have summarised the purposes, categories of personal data, legal basis and storage times of our processing in a number of tables below, before each of which a title has been attributed to it. The title corresponds to a place or general time of collection of personal data. Please note that these titles are meant to contextualise our processing and are not necessarily completely precise due to the dynamic nature of our collection.

#### 3. Where do we Collect your Personal Data?

Our main source of obtaining your personal data is through yourself: forms and emails etc.

In addition to yourself, we may obtain your personal data from other sources. This may include but not limited to your school, our partner organisations within the EYP network, our regional and local boards and our volunteers/officials during events. Furthermore, it is possible that we may obtain your personal information from publicly accessible sources such as the population registry.



### 4. How Is this Information Shared?

Events: During sessions or events in general we may share your personal information to venues and partners. For example, accommodation venues need the names of the participants living inside their premises; events inside governmental buildings or with certain guests of honour participating may require background checks on participants.

Events abroad: Upon participating in sessions abroad, we may share personal information to the organising partner organisation similar to those you shared with us before one of our sessions. These partner organisations are themselves data controllers for their processing of your personal data. You may find their contact details here: <u>https://eyp.org/get-involved/</u>

Auditors and advisors: We may share your personal information with our external auditors, advisors and legal advisors.

Grant givers: As outlined in chapter two, we may share your personal information to grant givers such as the Erasmus+ funding programme and the Swedish Agency for Youth and Civil Society.

Storage: We use G Suite from Google LCC and their subsidiaries, not least for digital storage and email.

#### Transfer of personal data to third country

In cases where personal data is processed outside the EU / EEA, there is either a decision by the Commission that the third country in guestion ensures an adequate level of protection or appropriate protection measures that ensure that your rights are protected.



### 5. What are your Privacy Rights?

We abide by the rules and regulations stipulated in the General Data Protection Regulation (GDPR), including not least the rights given to you as a data subject. You may at any time contact us through the contact details in chapter one of this policy to exercise your rights.

The Right of Access	This means that you have the right to request a record of our use of your personal data. You also have the right to receive a copy of the personal data we use free of charge. For any additional copies, we have the right to charge an administrative fee. If you make a request in electronic format, e.g. via e-mail, we will provide you with the information in a commonly used electronic format.
The Right to Rectification	We will, at your request or on your own initiative, correct, de-identify, delete or supplement information that we discover to be incorrect, incomplete or misleading. You also have the right to supplement with additional information if something relevant is missing. Please note that you have the burden of proof for demonstrating the inaccuracy or incompleteness of such data.
The Right to Erasure	<ul> <li>We will remove your personal data if we no longer have a valid reason to retain these. As such, erasure will occur if: <ol> <li>the personal data are no longer necessary in relation to the purpose for which they were processed,</li> <li>the personal data is based on consent and you choose to withdraw it, unless there is another legal ground for the processing,</li> </ol> </li> </ul>





	<ul> <li>However, the withdrawal does not affect the lawfulness of processing based on consent before its withdrawal.</li> </ul>
	III. you object to the processing and there are no overriding legitimate grounds for processing,
	IV. the personal data have been unlawfully processed,
	V. we have a legal obligation to erase the personal data.
	However, there may be legal requirements or other compelling reasons why we may not immediately delete your personal information. In such cases, we will then stop processing your personal data for purposes other than complying with the law or which are not necessary for any other compelling reason.
The Right to Restrict Processing	This means that we temporarily limit, i.e. freeze, the use of your personal data. You have the right to request a restriction when:
	I. you invoke the right to rectification during which we verify the accuracy of the data in question,
	II. we process the personal data unlawfully and you do not wish it to be erased,
	III. we no longer need the personal data for the purposes of the processing but they are required by you for the establishment, exercise or defence of legal claims,
	IV. you object to processing as per "the right to object", pending the verification whether our legitimate interest override those of yours.



The Right to Data Portability	You have the right to data portability. This means a right to obtain part of your personal data in a structured, generally used and machine-readable format and to transfer this data to another data controller. You are only entitled to data portability when the use of your personal data is automated and we base our use on your consent or on an agreement between you and us.
The Right to Object	You have the right to object to our processing of your personal data when our legal basis for such data is either legitimate interest or public interest. In such cases, we will only continue to process the data if we have compelling legitimate grounds which override your interests.
Rights in Relation to Automated Decision Making	EYP Sweden does not make use of automated decision making.
Right to Lodge a Complaint	You have the right to lodge a complaint with the Supervisory Authority, Datainspektionen, with regard to our processing of your personal information.

## 6. How will we Make Changes to this Policy?

EYP Sweden may make changes to this Policy at any time.
